## PRIVACY POLICY FOR DISTRIBUTORS AND RESELLERS GOODYEAR (THAILAND) PUBLIC COMPANY LIMITED

We, Goodyear (Thailand) Public Company Limited (the "**Company**," "we," "us," "our," or "ours"), values your right in respect to your Personal Data, and we are committed to the responsible collection, use, and disclosure ("**process" "processing**") of your Personal Data. We have adopted this Privacy Policy ("**Privacy Policy**") to explain the processing of your Personal Data under Thailand's Personal Data Protection Act B.E. 2562 (2019) ("**PDPA**").

The Company recommends you to read and understand this Privacy Policy where it relates to you. The content of this Privacy Policy is as follows.

# 1. Application of this Privacy Policy

This Privacy Policy applies to you if you are a distributor or reseller of the Company. In the case where the distributor or reseller is a juristic person, the Privacy Policy also applies to any persons, which are related to the distributor or reseller, including contact persons, directors, shareholders, and any representatives of the distributor or reseller ("Associated Person").

## 2. Key Definitions

"**Personal Data**" means any information relating to a natural person that enables such person to be identified, whether directly or indirectly, but not including the information of a deceased person in particular.

"Sensitive Personal Data" means any Personal Data as described in Section 26 of the PDPA, as amended from time to time, as well as any other applicable laws and regulations, which includes Personal Data pertaining to race, ethnicity, political, religious, or philosophical beliefs, sexual behavior, criminal records, health data, disability, labor union, genetic data, biometric data, or any other data that may similarly affect data subjects.

"PDPA" means the Personal Data Protection Act B.E. 2562 (2019), as amended from time to time, as well as any subordinate laws issued by virtue of the PDPA.

"PDPC" means the Personal Data Protection Commission.

## 3. The Types of Personal Data that We Process

In general, the Company will collect and process the following categories of your Personal Data:

Distributor/Reseller's Profile	The information in relation to each distributor or reseller of the Company, which includes information in relation to the performance of work under the agreement between the Company and you or your organization, such as sale orders and volumes, sale information, compensations, amount of works, scope of work, benefits and welfares, to which the Company provide, and other information collected during the distribution/reseller agreement.
Personal Data of Associated Persons	For example, full name, current address, registered address, LINE ID, office telephone number, mobile phone number, personal email address, office email address, identification card number, passport number, photographs, etc.
Sensitive Personal Data	In the case where the Company collects a copy of Thai identification card, which contains religion and/or blood type data, which are considered as Sensitive Personal Data under the PDPA. In this regard, the Company does not have an intention to collect or process such Sensitive Personal Data, which is appeared on the copy of your Thai identification card, i.e., religion and/or blood type. We therefore require you to omit, blind or cross out the information about religion and/or blood type, before surrendering/providing a copy of the Thai identification card to the Company, unless the copy of the Thai identification card is to be passed to local authority(ies) as required by law or such authority (ies).
	In the case where the full copy of the Thai identification card is collected, whereby the Sensitive Personal Data still appears on such Thai identification card, the Company may, at any time, blind or cross out the information about my religion and/or blood type from such document in order to comply with the PDPA that requires the Company to collect personal data to the extent that is necessary and relevant for its business operations.
Information as required by law	Any information required by the applicable laws, which the Company have to comply with. In this case, we will notify you if we need to collect certain Personal Data from you.

Legal claim related information	Any information, which may be necessary for the Company to establish, exercise, comply, or defense any legal claims. In this case, we will notify you if we need to collect certain Personal Data from you.

In the case where the Company will collect the Personal Data other than those prescribed in this Privacy Policy, the Company will inform you about the collection or the processing of the Personal Data and may request for your consent (if required), in accordance with the conditions prescribed by the PDPA.

### 4. The collection of the Personal Data

In general, the Company will collect your personal information directly when contacting you to enter into a contract with the Company and when communicating via e-mail, post, telephone, or handover of documents.

In certain cases, the Company may collect your Personal Data from other sources, such as when the Company collects the Personal Data of resellers from the distributors of the Company.

In the case of the Associated Person, the Company may also collect the Personal Data of the Associated Person directly from the data subject or through other persons from your organization when contacting with you or your organization via e-mail, post, or telephone.

Your Personal Data may also be collected through the CCTVs installed at our premises when you visit the Company or the Company's premises.

In the case you provide the Personal Data of any other persons to us, you warrant that you have informed such person about the processing of his/her Personal Data by the Company as explained in this Privacy Policy. In addition, if the consent for the processing of the Personal Data is required, you agree to assist the Company in obtaining the valid and enforceable consent from such person in accordance with the requirements prescribed in the PDPA.

In general, we will process your Personal Data for the following purposes:

#### 6. Disclosure of Your Personal Data

In processing Personal Data for the above purposes, it may be necessary for us to disclose your Personal Data to third parties, as follows:

- (a) to any of the Company's affiliates or group companies, both within and outside Thailand, for the purpose of internal management and administration work, to perform our contractual obligations, and for other purposes as identified in this Privacy Policy;
- (b) to third-party dealers, distributors, and suppliers, whether juristic persons or individuals;
- (c) to commercial banks and financial institution or companies, in the case your products and services are related to financial supports;
- (d) to external legal counsels in the case of debt collection, legal proceedings and legal execution;
- (e) to general counsels, advisors, auditors, and other experts;
- (f) to any competent regulatory, prosecuting, tax or governmental agencies, courts or other tribunals in any jurisdiction, including the Revenue Department;
- (g) to third parties in connection with a change of ownership in the Company, or any of its assets or properties; and
- (h) to any other persons or entities to whom the Company is required to make disclosure by applicable law, or whom the Company is permitted by you or your organization to disclose your Personal Data.

#### 7. The Cross-Border Transfer of the Personal Data

The Company regularly transfers, discloses, and give access of your Personal Data to its affiliates and group companies, and in certain circumstances, to third parties (e.g., service providers), located outside Thailand for processing of Personal Data mentioned in this Privacy Policy, e.g., for our internal management of data and operation of the business. The destination countries may have different data protection standards to those prescribed by the data protection authority in Thailand.

Notwithstanding that, the Company will ensure that it will protect your Personal Data by implementing adequate personal data protection standards for the transfer of your Personal Data outside Thailand, as prescribed under the PDPA.

### 8. Retention of the Personal Data

The Company retains your Personal Data for as long as is required in order to fulfil our contractual obligations and to maintain relationship between you, your organization, and the Company. However, in general, the Company will retain your Personal Data for ten (10) years after the cessation of our contractual relationship, or our last communications.

We may retain your Personal Data longer than the above period, only as otherwise permitted or specified by the applicable law.

### 9. Your Rights to Personal Data

You have the following rights with respect to your Personal Data:

- (a) To withdraw your consent, or to request a change to the scope of your consent;
- (b) To request that we confirm to you whether we have in possession any Personal Data that is related to you, to access or to obtain a copy of any such Personal Data, to request information about how we have processed or are processing your Personal Data, and to request that we disclose the source(s) of your Personal Data which has been obtained without your consent;
- (c) To request that we correct any Personal Data that is related to you;
- (d) In certain circumstances, to request that we delete or destroy your Personal Data;
- (e) In certain circumstances, to request to object the processing of your Personal Data;
- (f) In certain circumstances, to request that we transfer your Personal Data; and
- (g) In certain circumstances, to request suspension of the processing of your Personal Data.

We reserve the right not to comply with your request if this is appropriate, and as permitted by the applicable law.

In addition to the rights above, you have the right to file a complaint in relation to our processing of your Personal Data with the expert committee, in accordance with the procedures set out in the PDPA.

As far as permitted by the applicable law and regulations, we may be entitled to charge reasonable expenses incurred in respect to handling any of the above requests.
